NOTE FOR PHONE CONSULTATION:

- For patients not registered with MyMedicare, only Level B phone consultations may be bulk billed (if eligible). Level C and D phone consultations will be privately billed.
- For patients registered with MyMedicare, all phone consultation levels may be bulk billed (if eligible).

ADDITIONAL INFORMATION

Bulk Billing

Available only for Children under 16yo as well as Pensioners and Concession Card holders. *Note: Must have a valid Medicare and concession card.*

GPCCMPs and Health Assessments remain bulk billed for all.

Privately Billed Services

The following services are not bulk billed and must be paid at the time of the appointment:

- **Workers Compensation, Pre-Employment Medicals, Work-related Travel Vaccines, & Work-related Medical Certificate**

These are classified as work-related services and must be paid in full at the time of the appointment. Please note that they are **not covered by Medicare**. You may be able to claim Workers Compensation through your insurer or seek reimbursement for other work-related services from your employer.

- **Mental Health, Driving Medicals & Home Visits**

All Mental Health Plans, Reviews, Driving Medicals, and Home Visits are privately billed regardless of Medicare eligibility.

- **Forms for School or Sports**

Consultations that involve filling out school or sports forms are privately billed and are **not covered by Medicare**.

- **Personal Travel Vaccines**

Travel health consultations and vaccinations for personal travel are privately billed. If the practice is arranging your vaccine, payment is required before the vaccine can be ordered.

- **Medical Procedures**

All procedures will incur a Consumables + Consultation/Procedure Fee. This covers equipment and materials used during treatment.
